#### **6. Details of why we consider the Plan to be unsound**

##### **6.1 Inclusion of site LOU R2 without regard to the employment implications**

6.1.1 Paragraph 5.38 provides that “Policy SP 2 confirms the importance of identifying and delivering key infrastructure to support residential, traveller and employment growth across the District.”

6.1.2 However, site LOU R2 has been included for development without any recognition of its current employment status. The site is described as a ‘car park’ with no mention of Loughton Self Drive Ltd, a local business (with a current lease on the premises) trading from this location (see site assessment SR-0227 at <http://www.efdclocalplan.org/wp-content/uploads/2017/12/A-B1.4.2-Extract-for-Loughton-p141-181-of-full-Appendix-EB801Gviii.pdf> ).

6.1.3 This business has been successfully trading for 24 years, supplying a service to local businesses, services and residents alike, as well as providing employment for local people. It regularly sponsors local events and support local and national charities.

6.1.4 Additionally, the present bus and rail interchange at Debden is inadequate and involves a walk of approximately 150m between Debden Station and the bus terminus. The Station is not accessible for mobility-impaired people to travel westbound..

#### **7. Changes needed**

The Plan can be made sound by requiring EFDC to provide for the continuation of the current lease in any development of the site. Incidentally, this site should not be developed without measures to enhance the modal interchange and to make the Station 100% accessible for mobility-impaired people.
