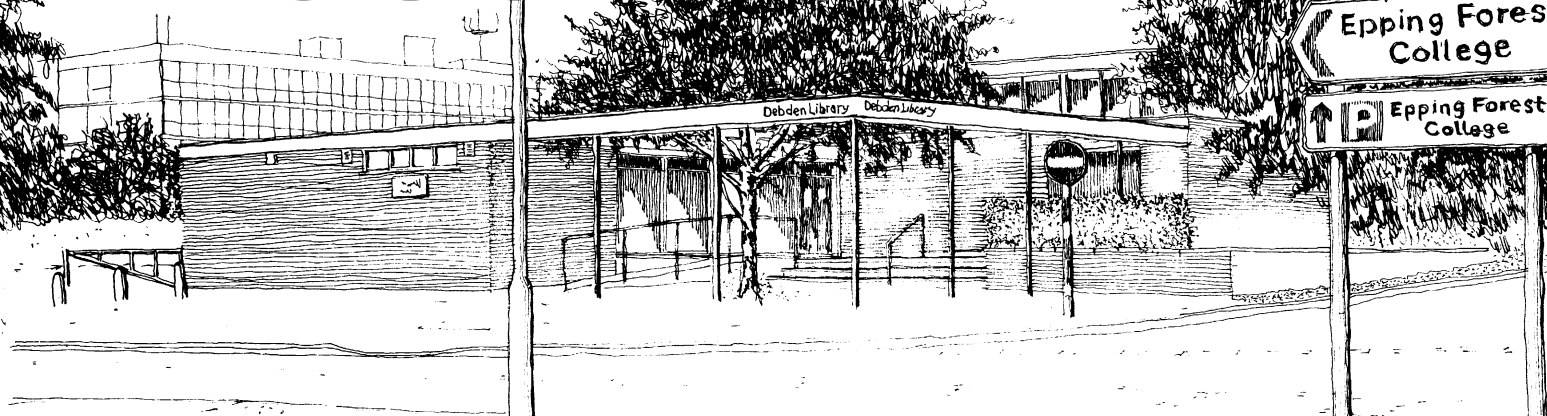

### IT'S A LOAD OF RUBBISH

Most people recognise the need to recycle more and to produce less waste, but the government is now bringing pressure to bear on local councils, including Epping Forest District Council (EFDC), by setting recycling targets for the coming year and imposing heavy fines if the targets are not met. Fines would be paid by all of us through our Council Tax. But making recycling improvements will also incur initial and ongoing costs. This is the problem EFDC has to solve.

Currently our district is above the national recycling average, at over 20%, but the European Union target is that at least 33% of all waste must be recycled by 2015. The introduction of Wheelie Bins is the method favoured by many councils and is being considered by EFDC. Among the possibilities currently being investigated, the favoured option seems to be fortnightly collections of different types of recyclables and 'residual waste' (rubbish to you and me). This would mean each household having a mixture of wheelie bins, blue boxes and sacks. We would all need to sort our rubbish more effectively, into green waste, glass, dry recyclables (cloth, paper etc) and residual rubbish.

Some Councillors and residents have expressed doubts about the proposal to introduce wheelie bins. They point out that initial costs will be high with the investment not only for the bins, which

will be provided free to households, but also for alteration to the collecting trucks. As the bins are slower to collect there may be the need for additional rounds. Also, they are not suitable for all households, and in terraced houses the bins and boxes being sited in front of the house would be to the detriment of the neighbourhood. Special 'big bin' arrangements would have to be made for blocks of flats.

It has been suggested that pilot schemes be tried in small areas before committing to the cost of a full changeover to wheelie bins.

When the proposal for the change was put to a meeting of the cabinet at EFDC, the vote was split 50/50. The Leader cast his vote to request further information.

### HIGH ROAD FUNDING SUCCESS

Funding for Loughton town centre improvements to the stretch between St Mary's Church and the traffic lights at The Drive, the second phase of the enhancement scheme, was finally officially approved at a meeting of EFDC's cabinet on 15 November. This is a success for LRA. Despite opposition from some of our political opponents, we have been keeping pressure on the Council to agree funding for this work.

The first phase, from Station Road to St Mary's, is already being funded by

Sainsburys as part of the condition for being allowed to build the store in Old Station Road.

No timings have yet been agreed, as there is further detailed design work to complete, but unofficially it is hoped that work on both phases will commence by July 2005 and be completed by November 2005 at the latest. LRA Councillors will do their best to ensure any disruption is kept to a minimum during this period.

The next objective is to secure funding for the third and fourth phases (the rest of the High Road), which remain unscheduled.

We are delighted that £100,000 has been approved for initial design studies on the Debden Broadway regeneration scheme. We understand that work on the Broadway scheme may start in 2006.

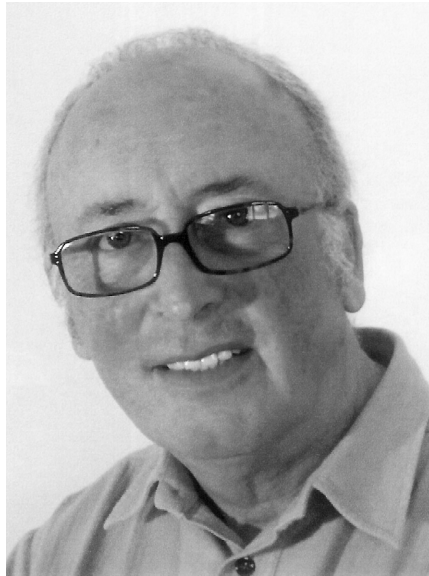
## PETER HOUSE ELECTED CHAIRMAN

## HAVE YOUR SAY IN LOCAL HEALTH SERVICES

### PATIENTS FORUM

A forum has been set up locally to make sure that you can have your say in local health services. Its members are local people interested in improving healthcare provision locally - they have become involved as a result of a Government initiative to establish local organisations to take the place of the (much lamented) Community Health Councils.

A local Patients Forum has got statutory backing, and can undertake a wide range of activities - for example, working with local communities to get their views on various aspects of the local health service, and presenting these findings to local hospitals and the Primary Care Trust; independently monitoring the quality of local services, by visiting surgeries, wards and so on and reporting back both to the public and the providers; and looking at how wider issues in the local community, such as social care, transport and housing, can affect health.

It's important that Forum members, who are all volunteers, come from a wide range of backgrounds, and have differing sorts of experiences and skills. If you would like to apply to become a member of your local forum (for

## ALL CHANGE AT THE LEISURE CENTRES

Responsibility for managing sports and leisure centres may be taken out of the hands of the District Council, as we reported in Loughton Life 18 months ago. Three tenders have been received for managing the centres in Epping Forest District, including Loughton Leisure Centre, and these are currently being evaluated. A final decision should be made in December, with the contract due to start next April. Although not ruled out, an in-house solution seems unlikely.

Further news on the dispute between the Council and the contractors who built Loughton Leisure Centre is it is moving towards resolution and should be settled within the next few months.

## ANOTHER ROUGH RIDE FOR POLICE AT AGM

Cllr Robert Chambers, Chairman of Essex Police Authority, was the speaker at LRA's public meeting on 26 October. The large audience heard him acknowledge that, despite his hopes, there had not been a significant improvement in the situation in Loughton since he addressed the AGM a year ago.

Questions and comments from the floor focused mainly on the level of anti-social behaviour across the whole of the town, the invisibility of the police and their lack of action when contacted by the public.

Mr Chambers hoped that within the next 12 months plans for a new call centre in Chelmsford would be announced. This should be particularly effective in improving the handling of non-999 calls, and would provide feedback to callers (which was largely lacking at present).

Epping Forest District Council had also been invited to send a representative to the meeting, to answer queries about parking in the town, but did not do so.

## NEWS FROM THE POLICE

The Loughton Policing Section reports some marked success over the past 6 months with regard to burglary and vehicle crime. We have managed to target and arrest a large number of persistent offenders, which we feel has led to a noticeable decrease in crime levels in Loughton, Chigwell and Buckhurst Hill.

We are also introducing a scheme to focus on one particular area at a time.

This will include targeting the chosen area for improvement schemes to better the general environment and providing high visibility police patrols. We will implement this in a selected area in the New Year, and then change on a yearly basis. We hope this will result in a large reduction in crime and anti social behaviour for these areas.

## SPARE TIME BLUES ?

There's nothing around here for young people to do ...

LRA is increasingly concerned about the plight of young people in Loughton. We recently hosted a meeting to discuss what is available to them and what more could be done.

While many young people take part in after-school activities and enjoy sport and organised leisure, others simply want to relax, meet up with friends and 'do their own thing'. The Loughton area lacks the commercial facilities of neighbouring London Boroughs - cinema, bowling, music venues - which youngsters (and others) would welcome nearer to home.

Voluntary clubs and organisations are struggling for cash, affordable premises and adult volunteers willing to lend a hand. Several already succeed and this marks a real achievement. But people do need to know what's on offer, and organisations need to work more closely together, and bring in young people themselves to plan activities.

Twelve organisations sent representatives to the meeting: Essex County Council youth service, Epping Forest District Council leisure services, Loughton Town Council, Epping Forest College, secondary schools, health workers, uniformed organisations, and voluntary sports clubs, police and churches, and several others have asked to be included in future talks.

A number of action points from the meeting are now being discussed by LRA's committee. Possibilities include an event where young people can meet up with providers, a look at the success of youth shelters elsewhere, talks with commercial leisure companies, a youth forum for Loughton, and better ways of supporting voluntary clubs. ## LOCAL HISTORIC BUILDINGS

In addition to the national register of listed buildings, local councils can also draw up their own list of Buildings of Local Architectural or Historic Interest. Such a list only offers limited protection to the buildings, but it does mean that any application regarding alterations to or development near these buildings would be given particular scrutiny.

Town councillor Chris Pond has been meeting EFDC's Conservation Officers about the 'Local List', which it is hoped will be finalised early in 2005. The draft list contains about 50 buildings, including for example the Wheatsheaf pub, Kings Green cottages, Lopping Hall, Dryads Hall and Loughton Lodge.

## SAVE GREEN VERGES

Throughout Loughton there are grassed verges designed specifically to provide an open aspect for residential areas. This is especially true on the Debden estate, which was designed as a garden suburb in a rural setting. Unfortunately the verges are now widely used for parking, with consequent damage and loss of grass. The residents can't be blamed, as they need somewhere to park their cars, but in some places this results in a churned up mud patch in winter.

The District Council have all but given up trying to repair the verges as they would be destroyed within a matter of days. Providing more and more cross-overs is not a solution, as this will destroy the green spaces for ever.

LRA District Councillor Ken Angold-Stephens proposes a detailed survey by the Council, to try to identify where new parking spaces could be created without unduly damaging the open green aspect of the areas. He also proposes the fitting of metal grids under vulnerable parts of grassed areas, so that the grass can grow through but the weight of a car would be supported. This solution has worked elsewhere. The proposal has yet to gain support within the Council, but we are hopeful.

Ken is collecting details of exact locations where verges are currently in dire need of renovation, and also those where roadside trees are dead or vandalised beyond rescuing. The Council officer responsible for verges and roadside trees will use the list when deciding what to include in the budget for planting. 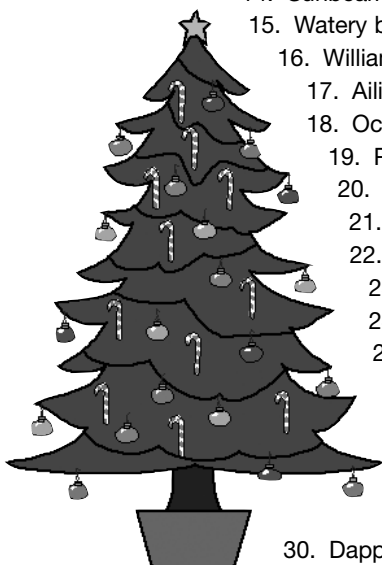
## DON'T GET CAUGHT OUT !
