LRA NEWS

Closure of Alderton Hill between Roding Road & the station for 5(?) weeks.

- **167 bus.** We have asked that the re-routed 167s (along Brook Road and Brooklyn Avenue) use the stops marked *Forest Road*. NEPP have confirmed that they have been contacted about enforcement of controls on parking/access etc on Brook Road and Brooklyn Avenue, but they haven't yet said what they'll be doing
- **High vehicles.** We're very grateful to the resident who spotted the need for signage at the top of Alderton Hill to stop any high vehicles coming down the hill – we certainly don't want any trying to “escape” down Roding Road, and hitting the bridge!
LRA Cllr Chris Pond got onto this immediately.



EOS bus services will ease on July 31st. LRA Cllr Chris Pond has been asking the County Council about the future of routes 66 and 87 - we understand that, at short notice, Arriva Kent (sic) have registered new routes which they'll run from August 1st. The new routes are broadly similar to the old EOS ones, except that route 66 reverts to half hourly instead of going to 3 per two hours.

A resident contacted LRA Cllr Chris Pond with concerns about the safety of the way the lights were positioned. Chris raised this with Highways, who confirmed an Inspector would check the site.

Bus 20 failed to stop.

LRA Cllr Chris Pond followed up a complaint that one morning the 0830am bus towards Walthamstow failed to stop at Homebase, Loughton.
TfL investigated, and have confirmed the bus was full and so didn't stop.

Recycling bins, Sainsbury's. LRA Cllr Amy Beales and I followed up a resident's concerns about fly-tipping by the recycling bins near Loughton station. Sainsbury's will try to keep an eye on this, and to speed up clear-ups. If you spot any-one dumping material here, please let us know their vehicle details (contact@LoughtonResidents.co.uk) and we'll pass them on.



Langston Road Retail Park. The District Council have responded to LRA Cllr Chris Roberts' complaints about overflowing rubbish bins and dirty pavements by promising more bins, and that the pavements will be cleaned by the site managers.

Fly-posting. There seems to have been a sudden increase in fly-posting in Loughton. We've been reporting any we see, to get them removed.

Noise from Loughton Leisure Centre. For the last 3 months, a family living nearby has been disturbed by noise from the Centre, sometimes at anti-social hours, caused by construction work, loud music and instructions being barked by gym instructors.

LRA Cllr Rose Brookes has been following this up, but so far the residents' complaints to the Centre and the District Council have had no effect. Because they have appointed a firm to run the Centre, the Council seems to be ducking out of its responsibility to control how the firm behaves.

LRA Cllr Chris Pond replied that the national scheme is financed county by county, so when a concessionary passenger boards a Loughton bus, the County Council pick up the bill.

Planning applications halted! Recent court decisions mean that the District Council is having to reconsider any planning applications within a specified distance of Epping Forest. There are potential implications for the new Local Plan. [Details](#).

Epstein's studio. LRA Cllr Stephen Pewsey reports that "the studio where world-famous sculptor Jacob Epstein created some of his most renowned works is in imminent danger of demolition.

Epstein lived at 49 Baldwins Hill in the 1930s before moving across the road to No. 50.

Property developers Millie Properties Ltd. have now applied for permission to destroy his studio, which is in the back garden of No. 49. OK, it's a sculptor's studio so it's not beautiful, but it has an important place in Loughton's cultural heritage and the international history of art. The District Council's Conservation Officer has not (so far) taken any steps to help preserve the building."

Epping Forest College merger –

- the [College's response](#) to concerns expressed by the District Council about the merger and about the future of the College's land
- **The Principal, Saboohi Famili, is leaving** on July 31st, apparently as a result of the merger.



Essex Police

- **The Epping Forest Community Hub** is now in operation; it's a joint venture between the police and the District Council, and there's a Police Sergeant and two experienced Police Constables funded and tasked by the Council. [More](#)
- **A female shoplifter** was arrested in Debden on July 12th and charged and remanded on two counts of theft with perhaps more charges to follow.[EFNW]
- **[2017 report on the efficiency of Essex Police](#)**. The link (from EFNW) will take you to the report – one area highlighted for improvement is: “The force should review its efforts to reduce the levels of abandoned 101 calls to ensure that the changes are effective, and it should seek to reduce the levels of abandonment to more acceptable levels as soon as possible. “
[We share this view (as do most police officers); we and EFNW also want the police to explain more clearly to residents why follow-up visits are often inappropriate (nothing more to be gained); and why individual reports can be vital to building up a picture of where to focus police efforts. And if you feel that the police have failed to act – for example to collect your CCTV evidence of a crime – please complain to the police. We have an energetic and committed Divisional Commander, and he needs to know when things go wrong (as they will in all large organisations).]

Road Closures for surface dressing phase 2*.

- **Epping New Road, Robin Hood Roundabout**, July 25th – 30th, (10am – 5pm) [Source](#)

***Surface Dressing Works Phase 2:** - The crews will spray the existing road surface with a coating of hot bitumen and cover it with stone chippings. The chippings are then rolled into the bitumen to form a water resistant protective layer which makes the road less slippery and extends its life. See [map & explanation](#) .



Footpath: Burton Road – 87-89 Torrington Drive may be closed for building work in Burton Road at any time until the work is finished.

Inconsiderate parking around primary schools. Sterling House, Langston Road. Galliard Homes have applied to the District Council for “prior approval” to change the building’s use from offices to 129 residential units.

[The LRA Plans Group will look at the details of the application. However, we are concerned that it may not be appropriate for land zoned long-term for employment uses (industrial or offices) to be converted in this way for short-term commercial gain.]

District Council housebuilding programme


The 51 flats and houses at Burton Road are scheduled for handover in December 2018,

GENERAL

Traffic disruption this weekend: Prudential RideLondon [Check your travel options](#)

The annual Prudential RideLondon festival of cycling is taking place over the weekend.

The routes will be closed to traffic. Road users are advised to avoid the affected areas

wherever possible. Buses will be on diversion or stop short of their destinations.

Tube and Rail will be the best way to get around during the weekend.

**ROAD
CLOSED**

On Saturday, the event route is in central London. Some roads will be closed from 05:00 until 19:30. On Sunday, the event routes are in east, central and south west London and in the affected parts of Surrey. Some roads will be closed from 04:00 until 20:00.

National Planning Policy Framework.

The Government has published a [revised version](#) of this top-level statement of the way in which the Planning system should be run. We will be carefully examining the changes.

Calls from solar energy companies. Trading Standards advise that there are companies ringing residents offering free checks, equipment, repairs and/or maintenance contracts on their solar panel systems – these are either fraudulent or significantly over-priced. More [here](#).

Extension of licensing for Houses in Multiple Occupation (HMOs) Until now, mandatory licensing of HMOs has applied only to the larger shared properties of 3 storeys or more with five or more people. Mandatory HMO licensing has now been extended to include all HMOs of any storey. Landlords of HMOs that are included within the new criteria have until October 2018 to apply to the District Council for a licence, after which they will be committing an offence.

Garden grabbing advert. LRA Cllr Stephen Pewsey spotted an ad by a “property services” firm offering help in finding a property in London – and in finding opportunities to build a second house in the grounds...no mention that this is normally strictly against Government policy (and would be resisted by Loughton Town Council and the LRA Plans Group).

Protecting your car.

[EFNW]

- **Key pouches.** EFNW has found evidence that the pouches you can use to protect your car keys from being accessed by thieves may fail to work after a time – possibly because of wear and tear in use. **Their advice:** check every-so-often by trying to open your car with the key in the bag.
- **And don't make it easy for thieves!**
This vehicle was spotted unattended in Buckhurst Hill, with items inside on display – please check your windows and doors when you leave your car!



Looking after you –what the District Council's Public Health team do (more [here](#) -item 5)

- **Food hygiene.** There are just over 1,200 registered food businesses in the District and just over half were routinely inspected, on a risk basis, last year (high risk food establishments are inspected every six months). Last year the team issued 258 written warnings and three Hygiene Improvement Notices, and there was one. Voluntary closure
- **Health and safety enforcement.** The Council is responsible for 4,469 premises and was required to carry out twelve intelligence led H&S inspections last year. It had also received 36 accident notifications, some of which could become lengthy cases.
- **Environmental pollution** cases range from major industrial users to residents' bonfires, or pollution from dry cleaners' solvents. Nitrogen oxide (NOx) levels are monitored across the District
- **Animal welfare:** Waltham Forest Borough Council deals with stray dogs in the District, under contract to our District Council. During 2017/18 35 dogs were collected (the majority were re-homed).
- **Other aspects:** pest control (114 complaints were received), dog fouling, animal welfare licensing (including licensing of dangerous dogs)
- **The Council's uniformed officers** deal with fly-tipping, littering, graffiti, fly-posting, noise nuisance complaints and many more. Fly-tipping in the District has increased and currently takes up 56% of officers'

time (2,338 incidents last year compared to 1,600 in 2010); noise nuisance complaints (1,384 were received) took up 33% of officers' time.

- **Licensing:** the Licensing team handle 4,500 licences per year under the Licensing Act 2003, Gambling Act 2005, Public Hire and Hackney Carriage licensing, plus special treatment licences, i.e. for tattooing
- **Major disasters;** the Council is a Category 1 Responder (the same level as Essex Police and Essex County Fire and Rescue Service) and takes part in multi-agency exercises for major disasters. Past major incidents include flooding of the River Roding, an unexploded bomb in Roydon at Dobbs Weir Road, a Debden gas explosion and a Loughton gas leak.
