Loughton's Water Supply

Residents may have noticed some recent short interruptions to their water supply and held their breath hoping there wouldn't be a repeat of the incidents in late 2021. Thankfully, supply was only interrupted for a short time.

As a reminder, if you have water supply problems:

- Thames Water does provide website and Twitter updates, although the latter isn't always up to date.
- Please continue to report any issues to Thames Water online or call 0800 316 9800. If the situation becomes urgent, do tell them and request bottled water.
- If you are out walking, keep an eye out for any new mains water leaks and report them too, as the leak may be the start of yet another problem.

As a precaution:

- If you're on the point of junking your cold water tank and hot water cylinder, think twice! The water in your tank and cylinder can refill even if the water pressure is low.
- Keep a supply of bottled water in the house for either drinking or flushing toilets.

If you, or someone you know, need a little extra support perhaps because of their health, disability, age, or if they're going through a difficult time in their life, Thames Water has a free Priority Services Register. This provides additional support when the water is off and when leaving the house is not possible, including bottled water deliveries where possible, by prioritising those who are dependent on water for medical needs

District Council apology for missed bin collections

The District Council has apologised for the ongoing issues with domestic waste and recycling collections.

Poor performance by waste and recycling contractor Biffa over Christmas and the New Year has compounded problems due to the severe weather earlier in December. Whilst the pre-Christmas cold snap exacerbated the current difficulties, the recent problems are part of a longer-term trend.

There are many causes to the current situation. The District Council may now be questioning the wisdom of redeveloping the old refuse vehicle maintenance depot on Langston Road and getting Biffa to maintain depots instead, along with a fleet of new lorries which may all need replacing at once. LRA has pointed this out in the past.

If your collection is missed, check to see if the Council already knows first at https://tinyurl.com/efdcmissedbin, and if they already know you should leave your bins out to be collected.

The Council has now decided to go to market and run a full procurement process for the Waste/Street Cleansing contract which expires in November 2024.

New charges for additional and larger bins

The District Council has decided that charges will be introduced when residents request an additional garden waste bin or a larger refuse bin above the standard size (although these are not currently available). In addition, if a bin is lost or a resident cannot produce it, residents will be charged for a replacement bin.

There would be discretion to consider any exceptions to this, as when collections are taking place bins can go missing when they do not go back outside the right property, or the rare occasion of when a person moves out of a property and takes the bins with them.

Where a bin can be repaired, the repair would continue to be free of charge to residents.

New District Local Plan

The consultation on changes to the Main Modifications of the Local Plan ended on $9^{\rm th}$ December.

LRA comment: LRA submitted further objections based on the inadequacy/illegality of the Epping Forest Special Area of Conservation (SAC) mitigation. The District Council Service Director for Planning Services, Nigel Richardson, has said the Inspector would consider these, probably during January.

LRA Farmers' Markets

The latest position is that we have a firm of market organisers which is interested in starting a weekly market in the High Road, but they have not been able to interest enough traders given recent economic uncertainty, price rises and problems hiring staff.

We will continue to work on starting a market in 2023.

Housing management services

As the District Council Cash Office on The Broadway has now closed, the District Council housing management team will be at the Oakwood Hill Community Hall on Longcroft Rise every Thursday from 9:30am to 12:30pm.

70 Trees for 70 Years of Queen Elizabeth II's reign

His Royal Highness the Duke of Gloucester, Ranger of Epping Forest, alongside civic leaders from the City of London Corporation, and the London Boroughs of Redbridge, Waltham Forest, and Newham, planted the final trees in a grove of 70 Silver Birch at Wanstead Flats in December.

They represent the 70 years of Queen Elizabeth II's reign and will be dedicated as part of The Queen's Green Canopy campaign. This is a tree planting initiative created to mark Queen Elizabeth II's Platinum Jubilee last June. Following her passing in September, HM The King agreed to extend the scheme to allow people to plant trees in her memory.

Avian flu

As avian flu has been detected in the Forest, you can find out what precautions you can take with wild, sick or dead birds at https://tinyurl.com/colavianflu

You can report a dead wild bird by calling 0345 933 5577 and you can report sick or injured wild birds to the RSPCA by calling 0300 123 4999.

If you have bird feeders in your garden, the RSPB advises good hygiene is key. Clean bird feeders and feeding stations weekly and change bird drinking and bathing water regularly. It is normal this time of year to see fewer birds in your garden and this is not linked to avian flu.

Planning & licensing

The LRA Plans Group (LRAPG) looks at all planning and licensing applications in the town and takes action where appropriate. It consults residents and supports, or objects to, individual applications as appropriate. It works entirely separately from LRA's Cllrs on Council planning committees. Where there are residents in flats above licensed premises, for example on the High Road, The Broadway or nearby, the LRAPG objects to late-night licensing applications.

Pyrles Lane former nursery site

This application proposes redevelopment of the site to provide 30 flats and 18 houses. In 2015 the site was granted outline planning permission for 36 flats and houses, however this expired. The District Council then failed to find a commercial developer prepared to buy the site so sold it to Qualis (which is a group of companies set up as Council subsidiaries in order to develop, own and maintain properties). This new application proposes an even more intensive plan for the site.

LRAPG is objecting to this application with the key concerns being:

- Only 8% of dwellings are affordable.
- The impact on the Epping Forest SAC from more traffic and pollution from exhaust fumes.
- Four storeys being too high the area is mainly two/three storey houses.
- The loss of trees and open green space.
- No provisions for supporting infrastructure such as doctor's surgeries and education provision.
- Consultation on an application for a previous, and now abandoned, scheme, opposed a less dense development.

Because this land is owned by the District Council, the application will be considered by the District-wide committee, where local knowledge is much less prevalent than in the usual area committee. Most of those Cllrs will know little about Loughton, Debden and the local area. You need to bear this in mind when commenting.

Reference EPF/2913/22. The formal consultation period ends 10 February.

Rear of 230-232 High Road (Corner of The Drive)

The application proposes adding eight flats to the rear of the existing building.

LRAPG has objected to this poorly designed development.

The lack of car parking will lead to pressure on adjacent streets which are already congested. The architecture is very poor; the rendered elements are clumsy and out of character with the area. The white rendered base will get dirty very quickly - good designers would not render the base of a building in white in a location like this. The air conditioning units for the shops at the rear will be lost and no consideration has been given to how they will be replaced. LRAPG has asked that the retail tenants on the High Road be asked to comment on this aspect of the development in order to ensure they are aware. The additional dwellings will also impact on the air quality to the Epping Forest SAC.

Reference EPF/2869/22. The formal consultation period ended on 19 January but you can still comment to the Council.

7 Forest Road

The application proposes adding two stories of office accommodation over existing retail shops.



LRAPG has objected to the proposed extension by reason

of its height, bulk and massing, which will stick out on this part of Forest Road to the visual detriment of Forest Road and this part of Loughton. LRAPG is also very concerned that the quality of the drawings are so poor, it is impossible to assess the quality of the design. The application should have been made invalid.

Reference EPF/2757/22. The formal consultation period ended on 16 January but you can still comment to the Council.

113 Church Hill - Damaged Hoarding and Rubbish

A resident contacted us to report that the building site at 113 Church Hill was in a poor state with rubbish on the site and the hoarding in a poor state.

John Walker of LRAPG inspected the site and has asked the District Council Planning Enforcement Team to contact the owners to ask them to re-do the hoarding and clear the rubbish. If the owners don't respond he has asked the team to issue a Section 215 notice under the Planning Act which will make the owners do it.

Street lighting

On some estates and former estates, the County Council does not own or service all the street lighting, but the District Council often does. The main place where this applies is Oakwood Hill Estate. This however also happens in, for example, parts of The Seymours, Trevelyan Close and part of Englands Lane.

As a tip, if the lamp has a white "witch's hat" atop or next to it, then it's a County Council light. If not, it's a District Council or private lamp. The Town Council owns no street lamps.

LRA Cllrs have noticed longer time gaps in getting lamps repaired and wonder, especially with old yellow 250-watt lamps, if this is designed to save money. In the County Council's defence, there has been a great shortage of spares (especially for older units) and if the electrical supply fails the contractor is under no obligation to act fast.

Loughton Leisure Centre

Several parents have complained to LRA Cllr Rose Brookes about swimming lessons at Loughton Leisure Centre being cancelled or classes being merged. She raised this at a Leisure Contract meeting,



along with increasing the cost of lessons again by another £2 to £32 a month. The Contract Manager responded by emphasising there was a national shortage of teachers as many instructors had left during the Pandemic when pools were closed. The company is subsidising the cost of training several teachers and they expected things to improve in January when they were qualified to teach. A new coordinator of swimming lessons was appointed in Loughton at the beginning of October, and she is improving communication. Eagle-eyed LRA Cllr David Wixley asked Rose to also report to Places Leisure that many gutters at Loughton Leisure Centre were blocked. Following his alert, the gutters were cleared out.

Cllr Pond's potholes progress

As a result of LRA Cllr Chris Pond nominating potholes to repair, the following potholes are amongst those scheduled for repair (which may have already been fixed):

- Old Station Road in the bus stop heading towards the station.
- Alderton Hill four outside No. 48, 52 and 54.
- In front of Loughton Station near the bus stops.

Chris can only report potholes in Loughton Central County Division.

Alderton ward councillors hold their monthly drop-in surgery every 1st Saturday of the month from 2pm-4pm at Guilloti Cafe on Borders Lane. Come by to discuss any ward issues. No registration or booking is needed.

Heathland restoration

Walking in the Forest, you may come across bare scrapes in the ground. These are part of conservation work being undertaken to help restore the Forest's heathlands. Competitive grasses and bracken have spread across the heathlands, crowding out other heathland species such as heather, mosses and lichens. These scrapes are being made to remove the competitive plants, to reveal the soil and to allow seeds of other heathland plants to germinate.

High Road noise complaints

We are aware of residents' complaints of noise recently from a restaurant on the High Road.

If you are suffering from noise, you can complain to the District Council at https://tinyurl.com/efdcnoise or you can call 01992 564608 during office hours or 01992 564000 at all other times. For complaints about noise from licensed premises, the District Council needs residents to report them. This is used as evidence in any investigation and to support a potential review of the premises licence.

Removal of speed humps on Smarts Lane

It was reported at the Local Highways Panel on 9th January that road humps in Smarts Lane will be removed north-west of Royal Oak Close and retained south-west thereof. It was also reported that Smarts Lane is not scheduled for resurfacing, contrary to what had been hoped, despite its condition.
